The first round of counseling for allotment of seats/streams/disciplines in different Medical Colleges of the State for the different Reserved Categories will be held on 19.05.2009 in Gandhi Bhawan, University of Kashmir, Hazratbal, Srinagar at 10.00 AM sharp till completion of the counseling. The Reserved Category candidates bearing the following roll numbers are directed to be present personally in the counseling. However, in exceptional cases where a candidate cannot appear personally due to some very emergent reason he/she should send his/her representative with special power of attorney mentioning therein his/her choice in preferential order. Choice once exercised will not be changed later on. In case any candidate fails to appear personally or through his/her representative or guardian he/she will lose his/her claim for a seat of his/her choice and will be entitled to the residual seat if any available at the time of his/her reporting. All the candidates/their representatives are required to keep the admit cards with them in the counseling. The allotment of seats shall be made only on the basis of merit/choice of the candidate and availability of the seat.
