Applications are invited from eligible candidates of Jammu and Kashmir State to appear in the Entrance Test for admission to B.Ed course for the Academic session 2009 in the **Government College of Education, M.A Road Srinagar**. The selection of candidates will be governed by the Rules and guidelines as contained in the Information Brochure of the Board.

02. Submission of Application Form:-

The prescribed Application Form along with the Information Brochure will be available for sale from **25.02.2009 to 07.03.2009** on all working days from the offices of the Board of Professional Entrance Examinations, at **9-A Polo view Srinagar and 401 4th floor South Block, Bahu Plaza, Jammu** against a non-refundable Bank Draft of Rs.850/- (Rs. eight hundred and fifty) only, drawn in favour of Financial Advisor/Chief Accounts Officer, Board of Professional Entrance Examinations, payable at RCC Jammu/Srinagar. The Application Forms, complete in all respects will be received in the two offices of the Board at Jammu and Srinagar from **26.02.2009 to 10.03.2009**, on all working days. **The Application Form can also be submitted on- line through our website <http://jkbpee.nic.in> from 25.02.2009 to 04.03.2009.** For detailed information for submission of online Application Forms see our website.

03. Eligibility:-

I. The candidate must:

- a). be a permanent resident of J&K State;
- b). have passed B.A/B.Sc./B.Com (Final) Examination under 10+2+3 pattern.

II. Candidates Applying under Open Merit Category must have obtained not less than 50% marks in aggregate in the qualifying Examination. Candidates applying under Reserved Categories, as specified in SRO 294 of 2005, must have secured 40% marks in aggregate.

04. Documents to be enclosed:-

I. Attested Photostat copy of the Date of Birth (Matriculation Certificate/Secondary School Certificate) from the Board of School Education.

II. Certificate of Permanent Resident of J&K State.

III. The relevant category certificate in case of candidates seeking selection under any of the reserved categories.

IV. Marks sheet of B.A/B.Sc./B.Com Final under 10+2+3 pattern.

V. The Application Form with “**under process certificate**” will not be entertained and in the absence of valid reserved category certificate, the candidate shall be considered in **Open Merit** Category if otherwise eligible for the same. Selected candidates shall have to produce all the certificates in **Original** at the time of admission or as and when asked by the BOPEE.

05. Issue of Admit Cards and Date of Test:-

Information with regard to issue of Admit Cards, Venues of the Entrance Examination and the Date and time of the Test will be issued separately in due course of time.
